**2.1 Inspection Guarantee**

All vehicles are guaranteed to match their online descriptions. Our 14-day satisfaction guarantee applies when:

- Vehicle is returned in original condition
- Written notice is received within 14 calendar days

**2.2 Inspection Limitations**

Buyer acknowledges that:

- Inspections cannot reveal all potential mechanical issues
- RepoZyth cannot guarantee future performance
- Vehicle history reports may contain incomplete information
- Buyer bears final responsibility for vehicle evaluation

**III. PAYMENT POLICY**

### 3.1 Accepted Payment Methods

For transaction security, we exclusively accept bank wire transfers.

### 3.2 Payment Instructions

Successful bidders will receive within 24 hours:

- Recipient banking details
- Routing information
- Unique wire reference number
- Detailed payment deadline

*Buyer must monitor both primary inbox and spam folder for this communication.*

### 3.3 Payment Default Consequences

Failure to remit payment constitutes breach of contract and will result in:

- Immediate account suspension
- Forfeiture of all deposits
- Liquidated damages equal to 10% of purchase price
- Reporting to credit bureaus
- Potential civil litigation under Georgia UCC § 2-703

## IV. DELIVERY SERVICES

### 4.1 Delivery Terms

- **Service Area:** Nationwide coverage
- **Dispatch Schedule:** Weekly shipments every Monday
- **Transport Methods:**
  - Enclosed trailers for standard vehicles
  - Flatbed/lowboy trailers for oversized assets
  - Specialized equipment for non-operational RVs

### 4.2 Delivery Pricing

- **Free Delivery:** First 500 miles
- **Extended Distance:** \$1/mile thereafter
- **Timelines:**
  - 14-day maximum for U.S. deliveries
  - 22-day maximum for Canadian deliveries
- **Insurance Coverage:** \$25,000-\$3,000,000 policies based on vehicle value

## V. WARRANTY PROGRAM

### 5.1 Standard Coverage

All purchases include a 6-month limited warranty covering mechanical components while excluding:

- Cosmetic imperfections (documented in listings)

Optional extension available for up to 5 years total coverage. Terms include:

- Co-Pay: Up to \$50 per service visit (adjustable)
- Non-Transferable: Valid only for original purchaser

## **VI. RETURN POLICY**

### **6.1 14-Day Satisfaction Guarantee**

## **VII. TITLE & OWNERSHIP TRANSFER**

### **7.1 Title Transfer Requirements**

Buyer must:

- a) Provide valid government-issued photo ID
- b) Complete all required DMV paperwork
- c) Pay all applicable taxes and fees
- d) Maintain adequate insurance coverage

### **7.2 Title Delay Penalties**

Failure to complete title transfer within 30 days will result in:

- b) Suspension of warranty coverage
- c) Possible reporting to state authorities

## **VIII. GENERAL PROVISIONS**

### **8.1 Governing Law**

This Agreement shall be governed by Georgia law.

### **8.2 Attorney's Fees**

Prevailing party in any dispute shall be entitled to recover reasonable attorney's fees and costs.

### **8.3 Entire Agreement**

This document supersedes all prior agreements and may only be modified in writing signed by both parties.

## **IX. DISPUTE RESOLUTION**

### **9.1 Mandatory Arbitration**

Any disputes arising from this agreement shall be resolved through binding arbitration in Kearney, Georgia under the rules of the American Arbitration Association.

### **9.2 Class Action Waiver**

Buyer waives any right to participate in class actions or collective claims against RepoZyth.

### **9.3 Jurisdiction**

All legal proceedings not subject to arbitration shall be filed exclusively in Georgia courts.
